- vi. I understand that as my child is participating in WCPC Youth Ministry events, I will occasionally be asked to help as a driver, chaperone, cook and volunteer in some other capacity in such events;
- vii. In the event that reasonable attempts to contact us at the above-provided telephone numbers and e-mail addresses have been unsuccessful I hereby give my consent for the administration of any treatment for Youth/Tween deemed necessary;
- viii. I hereby grant permission for WCPC's Youth Ministry leaders, sponsors and chaperones to take whatever steps they believe may be necessary to obtain emergency medical care for Youth;
- ix. I will not hold WCPC or its Youth Ministry leaders, sponsors and chaperones liable for citations or accidents occurring during travel to, from or during a WCPC Youth Ministry sponsored event, stemming from the Youth's driving alone or from the Youth nonuse or inappropriate use of a seatbelt/shoulder restraint;
- x. I will not hold WCPC or its Youth Ministry leaders, sponsors and chaperones liable for loss of or damage to any personal property, including but not limited to cell phones, iPods/iPads, computers, electronic players/gamers and cameras, etc.;
- xi. I give my consent for my child to be photographed and/or videotaped for the WCPC newsletter and website, overhead projection purposes and publicity, understanding that it is against WCPC policy to publish the last names of any of its children or youth; and
- xii. I understand that it is my responsibility to update this form if any information changes during the Year.

2017-2018 COVENANT FOR YOUTH AND PARENTS

For Parents/Guardians to read in its entirety with their WCPC Children, and sign together

The Youth Ministry of WCPC desires to create a safe Christian community for all minors and adults alike. Using a covenant is a Biblical way to memorialize your commitment to yourself and to the community. This is not to be seen as a list of rules but a list of needs that must be met to keep the community a safe and trustworthy place. We understand that non-compliance with the covenant, especially regarding smoking, the use of illegal substances and alcoholic beverages, use of foul language, and inappropriate sexual conduct will result in consequences. For major offenses, such consequences will result in the immediate phoning of the parent to arrange for the return home of the Youth at the parents' expense. Minor offenses will result in one warning, with subsequent offenses resulting in appropriate consequences and/or the phoning of the parent to arrange for the return home of the Youth at the parents' expense. Non-compliance with the covenant regarding the use of cellular phones, personal entertainment systems or other personal devices will result in one warning, with subsequent offenses resulting in the Youth Ministry leader, or a sponsor/advisor/chaperone, keeping the device until the trip, outing or other event comes to an end.

YOUTH COVENANT

I understand that WCPC Youth events are faith-building, life-enhancing, and friend gathering events. I commit to take part fully in each event I am attending, giving it 100% and I commit to treat people and property with respect at all times. I will stick to the agenda and not wander from the premises. WCPC is a Creation Care Congregation and I will represent it as such. I will not use my cell phone during events except for emergencies. If I need to leave the large group for any reason I will inform the leaders, letting them know where I am, at all times. I will adhere to the "Rule of Three." I will not participate in any behaviors that tear down the event or any of the participants in it, including but not limited to bullying. I will strive to include everyone in the activities and be welcoming to all people. I will wear clothes that are respectable and appropriate for the event or trip I am attending as well as show respect for other individuals' "personal space" and their own "individually set boundaries." I understand that I participate in group to be a part of the Body of Christ, and will strive to form the respectful bonds of friendship and inclusive trust with my peers of all genders. I will not intentionally seek romantic or other inappropriate relationships with anyone among the program. I understand that regarding any inappropriate behavior, offenses will result in appropriate consequences: either warnings, with subsequent offenses resulting in appropriate consequences and/or, depending on the range of the inappropriate behavior determined by the judgement of the leaders of the event, the immediate phoning of the parent to arrange for the return home of the Youth at the parents' expense. I understand that if I continue to act in ways that break the bonds of this covenant, after appropriate warnings, leader intervention, prayerful thought and parental contact, as a last resort, I may be asked to not participate in group for a time to be determined by leadership and WCPC staff. Above all, I understand that I am a child of God, a representative of Christ and WCPC, I will act in such a way which glorifies God, respects others, and is consistent with Christ's teaching, and the policies and procedures of The Woodlands Community Presbyterian Church.
