# Safety and Emergency Steering Team Minutes June 6, 2018

Attendees: Bruce Lee, Jerry Dowling, Sheree Fleming, Matthew Jensen, Jeanne Bonnette

Bruce Lee opened with prayer.

#### Old Business:

Jerry confirmed that Susan Duncan believes that there are no Sunday School teachers or nursery workers that carry firearms. We plan to include a statement in the safety manual that requires children's teachers or caregivers to secure any legally-carried firearms in their vehicles or an alternate locked location while classes are in session.

Jerry has drafted procedures for handling hostile intruders and active shooters. He noted that we should define the positions authorized to summon first responders in any type of emergency. When an emergency occurs, reasonable efforts should be made to contact one of these individuals before summoning first responders. The proposed positions are:

- Pastor or Associate Pastor
- Director of Early Learning Program
- Director of Children's Ministries
- Financial Administrator
- Director of Communications
- Head Usher/Ushers

If none of these individuals can be quickly reached, meeting leaders/hosts should contact first responders. One of the pastors should be informed about any emergency on the property as soon as possible.

The team will encourage all meeting leaders to begin meetings by noting who will be responsible for calling first responders and for familiarizing attendees with the emergency exits.

Fifteen people attended the class covering CPR, AED operation, and community safety that was held on May 21. Matthew has scheduled CPR/AED training for the Gathering Place caregivers and for VBS teachers. He is available to deliver training to other WCPC groups upon request. We plan to conduct another class or demonstration sometime in the fall. On June 3, three team members hosted the Welcome Center and a table in the breezeway aimed at raising awareness of the AED and other emergency equipment on the campus.

Sheree completed the Church Security Assessment questionnaire and added several items to the Issues list for the team's consideration. Diagrams of church buildings with safety equipment marked have been completed. These have been provided to the Fire and Sheriff's Departments for loading into their systems. This makes them available on the monitors in first responders' vehicles. They are being posted on bulletin boards and at other locations, and will also be included in our training materials.

Matthew will develop instructions for using the Page feature on land-line phones. These will be posted with emergency phone numbers at these phones. We are evaluating walkie-talkie systems that would allow quick communication among all parts of the campus in an emergency. Jerry will develop proposed handset locations. He will also provide a crank or battery-powered radio for the office, which can be used to monitor the National Weather Service when the power is out.

Bruce has discussed the issue of the building lock codes with David Jones and will work with Shirley Barclay to change the master code. He will meet again with Dawson Lock to address a number of questions about options for improving building locks. He will document procedures for locking up buildings at the end of each day for inclusion on the Building Use Forms. We will also include them in the safety training materials that we plan to provide to staff and group leaders in August.

#### **New Business:**

Sheriff's Deputies Daniel Pena and Jason Henson toured the campus on May 31 and made a number of suggestions for improving security. This includes assigning someone to monitor the sanctuary narthex and parking lots during worship. We plan to invite Deputy Hanson back in the fall to undertake a formal risk assessment. This will include a review of ELP security and night visits. We will receive a written report with photos.

# Safety and Emergency Steering Team Minutes June 6, 2018

We plan to draft a Safety and Emergency Response manual over the summer and to create training materials based on the manual. These will be provided for use in August/early September during kickoff meetings for ELP and Sunday School teachers as well as group leaders. Training may include physical inspection of safety equipment and facilities.

We reviewed and updated the Issues and Next Steps spreadsheet that the team uses to track and plan our work. We also reviewed the items that have been classified as high or medium priority maintenance items and building modifications. The top priority at this time is purchasing a second AED to be installed in the Hendricks Education Building. Work is underway on some of the most urgent items, including repair of a relay switch in the sanctuary HVAC ducts that prevents smoke from being blown through the ducts, repair or replacement of emergency exit lights that are out, and installing a crash bar on the kitchen emergency exit door.

Work will continue on facility improvements and training development over the summer. The next meeting is planned for September.

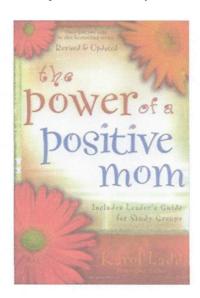
